As President of The Umbrella Club, I want to thank everyone for their continued support during 2022. We had a wonderful year that saw our revenue increase to \$551,080 which continues to rise despite the aftereffects of COVID-19 and challenging economic times. Many thanks to our supporters and the hard work and dedication of our fellow members.

Our Good & Welfare Committee, who is responsible for finding and screening the sick and disabled recipients that we support through our charitable programs, did a truly outstanding job! We donated \$971,305, which includes a \$500,000 Capital Gift to the Stamford Hospital Maternity and Delivery Unit, more specifically The Cohen Neonatal Intensive Care Unit (NICU). This was an extraordinary opportunity for the Club as we have partnered with Stamford Health for many years and our Capital Gift will address the critical upgrades of the NICU.

For 2022, we began to account for our financial results on an accrual basis which more closely reflects how we operate and is in accordance with Generally Accepted Accounting Principles (GAAP). Our Auditors, Fiondella, Milone and LaSaracina, LLP have given us a "Clean Audit Opinion" for the 4th year in a row since we began external audits. With our strong financial results and management, I'm proud that we have been able to expand our assistance to the general community and we remain steadfast in helping as many families as possible and children in need throughout Fairfield County.





Revenues, Program Expenses and Changes in Total Liabilities Plus Net Assets Presented on an Accrual Basis for the Year Ending December 31, 2022



During 2022, the Organization made an unconditional promise to give in the amount of \$500,000 over a ten-year period to the Stamford Hospital Maternity Care, Labor and Delivery Unit, more specifically The Cohen Neonatal Intensive Care Unit (NICU). The donation was made for a critical upgrade and overhaul of the NICU. This donation was accrued for in 2022 and is represented in Charitable Program Expenses of \$971,305. However, as of December 31, 2022, donations payable totaled \$428,200, which includes a current portion of \$50,000.

The Umbrella Club operates under the financial guidelines for charities as prescribed by the standards of the Better Business Bureau. As a 501 (c) 3 organization, annual tax return filings are available on-line to the public. The Books and Records of the Club are audited annually by an outside accounting firm: FML CPA's, Fiondella, Milone & LaSaracina LLP of **Glastonbury, Connecticut.**
